## What your gift will mean to Leeds Lieder:



- ◆ Ticket sales provide only 20% of Leeds Lieder's annual income
- ◆ Our generous Friends provide a further 20%

- ◆ Leeds Lieder could not survive without the unpaid time commitment of Committee members
